<b>Electing Officers and Area Reps</b>	Art VI, Secs 1, 2, & 6	None	Nominating Committee announces in May	Vote in person at a meeting; quorum and majority vote required	Vote in person or absentee; quorum and simple majority required
<b>Removing Officer or Area Rep</b>	Art VI, Sec 3	Special meeting announced in newsletter prior to meeting date	Special meeting published by e-blast or in newsletter prior to meeting date	Vote in person at special meeting; quorum and supermajority vote required	Vote in person or absentee; quorum and supermajority required
<b>Establishing the Nominating Committee</b>	Art VI, Sec 5	None	None	Vote in person at May meeting; the three who receive "the largest number of votes" serve on committee	"Informal election" only in case more than three members volunteer to serve; vote in person only; simple majority but no quorum required
<b>Replacing Board Member following Vacancy</b>	Art VI, Sec 8	None	Nominated at meeting following vacancy	Vote in person at a meeting; quorum and majority vote required by reference to Art VI, Secs 1 & 2	Only in case of more than one nominee, vote in person at or absentee by the second meeting following vacancy; quorum and simple majority required
<b>Membership Removal</b>	Art IV, Sec 1/2	None	None	Vote in person at a meeting; quorum and simple majority required	Vote in person or absentee (if notice is possible/given); quorum and simple majority required
